WHEREAS I understand I will be attending rides and events which are hosted by the Chrome Divas of Southern California. This is a membership form. This Release shall extend to any and all Rides/Events to which I might attend and/or participate with the Chrome Divas, Inc. and/or the Chrome Divas of Southern California (collectively referenced herein as "The Chrome Divas").

WHEREAS I am experienced in and familiar with the operation of motorcycles and fully understand the risks and dangers inherent in motorcycling. I am voluntarily participating in this group, and I expressly agree to assume the entire risk of any accidents or personal injury, including death, which I might sustain to my person and property as a result of my participation.

WHEREAS I understand and acknowledge that there may be alcoholic beverages served by third parties at the various events but such beverages are not being provided by The Chrome Divas. Any consumption of alcoholic beverages will be at the will of the undersigned. I further understand that if I voluntarily consume alcoholic beverages I agree I will comply with all of the laws governing the public and/or private consumption of alcohol. I agree that under no circumstances will I, as a driver or passenger, ride or participate as a passenger if I am even the slightest bit impaired.

WHEREAS I further certify that I am not relying on any statements or representations by anyone as to the license and insurance status of any other participant. However, I hereby state that I have valid auto/motorcycle insurance and a valid M1Class driver's license or Permit.

IN CONSIDERATION OF ALL OF THE FOREGOING, AND BEING PERMITTED TO BE PRESENT AT THE RIDE/EVENT,

I, _____ (*FULL LEGAL NAME*) "RELEASOR," on my own behalf and on behalf of my heirs, personal representatives, successors and assigns), hereby release and hold harmless The Chrome Divas, all of their current and former officers, administrators, agents, representatives, shareholders, directors, employees, executors, successors, assigns, subsidiaries, predecessor or successor companies, chapter members, and any other individuals in their representative or authorized capacity acting on behalf The Chrome Divas, as well as any other participant, attendee or anyone related to any of the above persons ("Released Parties"), from any and all liabilities, claims, demands, rights and causes of action, damages, costs or expenses of any kind whatsoever which may be directly or indirectly related to my membership and participation.

I FURTHER AGREE not to sue or take any action of any kind against any of the released parties for any reason to the maximum extent authorized by law and in compliance with California Civil Code § 1668.

For the purpose of implementing this Release, I expressly acknowledge that this Release is intended to include all claims which the parties do not know or suspect exist in their favor at the time of the executions hereof, including specifically, without limitation, those described in § 1542 of the California Civil Code, which section reads as follows:

"A general release does not extend to claims which the Releasor does not know or suspect exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the Release Parties."
